Subscriptions

When registering for *ZooMonitor*, you are given a 30-day free trial. Your 30-day period begins when you sign in to your admin portal and save billing information. At the end of this free trial, you will be automatically billed for an annual subscription based on the pricing plan for your account. Your subscription will renew until canceled. You may cancel your subscription at any time in the admin portal of your *ZooMonitor* account. For accounts that require greater storage space than offered on the Base Plan, you will be required to upgrade your account to a Pro Plan. You must consent to upgrade your plan to continue using the Service.

Termination of Services
